

INSCALE TECHNOLOGIES/AVSIGHT USER GROUP SUMMIT PROGRAM TERMS & CONDITIONS

These terms and conditions apply to attendee registrations for The AvSight User Group Summit (the "Event") organized by Inscale Technologies/AvSight ("we/our/us"),

Your registration constitutes an offer to Inscale Technologies/AvSight to attend an Event. All registrations are subject to acceptance by Inscale Technologies/AvSight. If your registration is received in advance of the Event, it will either (i) be confirmed in writing (including, without limitation, by email), or (ii) if written confirmation is not sent within 14 days of us receiving your registration, be deemed to be confirmed unless we notify you otherwise. If your registration is received only at the Event itself, it will be confirmed by the act of Inscale Technologies/AvSight permitting you entrance to the Event. A contract between Inscale Technologies/AvSight and you will only be formed upon such confirmation. Inscale Technologies/AvSight reserves the right to refuse to accept any registration. The Event is a private event open to AvSight users only, and not open to the public. Non-AvSight users such as consultants and partners will be permitted to attend if approved by Inscale Technologies/AvSight. Approvals are not guaranteed and are considered on a case by case basis.

Your registration is issued for your personal use only. You may not procure registrations as an agent for any third party, sell or otherwise transfer your registration to others or exploit your registration commercially or non-commercially in any way.

Inscale Technologies/AvSight reserves the right at any time to change the format, participants, content, location and timing or any other aspect of an Event, in each case without liability. Inscale Technologies/AvSight reserves the right to withdraw any registration after confirmation without liability. Inscale Technologies/AvSight reserves the right to postpone or cancel an Event without liability at any time for any reason (whether or not due to causes beyond our reasonable control). Where an Event is postponed, your registration will be valid for any re-scheduled edition of that Event (unless we notify you otherwise).

Inscale Technologies/AvSight reserves the right without liability to refuse admission to, or to eject from, the Event, any person in its absolute discretion, including (without limitation) any person who fails to comply with these terms and conditions or who, in the opinion of Inscale Technologies/AvSight, represents a security risk, nuisance or annoyance to the running of the Event. You agree to comply with all reasonable instructions issued by Inscale Technologies/AvSight, the venue owners, security personnel and/or management at the Event. In the event that a person is ejected for cause, they are not entitled to a full or partial refund or any other compensation.

Payments: All bookings made prior to the event must be paid in full to guarantee registration. Once payment has been received, an email confirmation will be sent. If payment is not made at the time of booking, registration will be provisional. If the event sells out between the time of registration and payment, your attendance is not guaranteed.

Early Bird Rate: In order to qualify for any “early bird” rates or discounts, booking and payment must be received before the deadline date listed.

Cancellation Policy: Registration fees are not refundable. In the event that you are unable to attend, you can transfer your registration to another colleague. By submitting your registration, you authorize Inscale Technologies/AvSight to invoice you for any unpaid portion of your registration fee. If a registered delegate does not cancel and fails to attend the conference, this will be treated as a cancellation. Should Inscale Technologies/AvSight postpone an event, your registration will automatically roll over to the new date. Alternatively, you can elect to receive a refund of registration fees within 30 days of being notified of the event postponement and intent to rollover registration. After this period of time, the rollover will be treated as a registration. If an event is canceled, a refund will be issued following notification of event cancellation.

Adjustment of Registration Fees: After a delegate’s registration is completed, Inscale Technologies/AvSight reserves the right to review the information provided by the delegate and adjust the registration ticket type and fee if it is found that the information provided by the attendee has been misrepresented, false or incorrect. Any adjustment to fees will be charged directly to the payment method on file.

Reportable Breach: a breach of security leading to the accidental or unlawful destruction, loss, alteration, unauthorized disclosure of, or access to, personal data transmitted, stored or otherwise processed.

The terms personal data, controller, processor, processing, data subject and supervisory authority shall have the meanings ascribed to them under the GDPR.

For the purposes of either party’s processing of personal data in connection therewith, the parties agree that each party acts as a data controller. Each party shall (i) only process personal data in compliance with, and shall not cause itself or the other party to be in breach of, Data Protection Law, and (ii) act reasonably in providing such information and assistance as the other party may reasonably request to enable the other party to comply with its obligations under Data Protection Law. If either party becomes aware of a Reportable Breach relating to the processing of personal data in connection with the Order Form, it shall (i) provide the other party with reasonable details of such Reportable Breach without undue delay, and (ii) act reasonably in co-operating with the other party in respect of any communications or notifications to be issued to any data subjects and/or supervisory authorities in respect of the Reportable Breach. If either party receives any communication from any supervisory authority relating to the processing of personal data in connection with the Order Form, it shall (i) provide the other party with reasonable details of such communication, and (ii) act reasonably in co- operating with the other party in respect of any response to the same.

The personal information which you provide to Inscale Technologies/AvSight will be held by us on a database. Your personal information may be shared with government entities and regulatory authorities as required by law. The use that such government entities and regulatory authorities make of your personal information is outside of Inscale Technologies/AvSight’s control and we do not accept any liability in this regard.

Photographs, Publicity Material, Radio and Television and Print Media: Inscale Technologies/AvSight reserves the sole right to use any photographs, recordings, electronic images or publicity material received by or obtained by Inscale Technologies/AvSight in the course of the event, for whatever use deemed proper by the Inscale Technologies/AvSight. Inscale Technologies/AvSight has the exclusive right to include photographic, video and other visual portrayals of Attendees and Sponsors including its contents, in any pictorial medium of any nature whatsoever for the purpose of trade, advertising, sales, publicity and otherwise, without compensation to the Attendee or Sponsor and all rights titled and interest bearing (including all worldwide copyrights therein) will be Inscale Technologies/AvSight's sole property, free of any claims of Attendee or Sponsor or any persons deriving any rights or interest from the Attendee or Sponsor. All unauthorized filming, sound recording and photography, or the unauthorized transmitting of audio or visual material, data or information, is expressly prohibited at the Event.

Credentials: Inscale Technologies/AvSight-issued credentials are the sole property of the Event Organizer and must be surrendered upon demand to Inscale Technologies/AvSight representatives. Inscale Technologies/AvSight -issued credentials must be prominently displayed while at the conference or designated off-site activities. False certification of an individual as an attendee or exhibitor's representative, misuse of an attendee badge, or any other method or device used to assist unauthorized personnel to gain admittance to the Event, will be just cause for expelling the attendee and his/her representative(s) from the conference and/or banning them from future entrance into the conference, without obligation on the part of Inscale Technologies/AvSight for refund of any fees. The attendee, waives any rights or claims for damages arising out of the enforcement of this rule.

Admittance: In its sole discretion and without refund, Inscale Technologies/AvSight reserves the right to refuse admittance to or expel from the Event anyone that it determines is behaving in a manner that could be disruptive to the Event or any other attendee.

Disclaimer: Inscale Technologies/AvSight may at any time, with or without giving notice, in its absolute discretion and without giving any reason, change, cancel or postpone the Event, change its venue or any of the other published particulars, or withdraw any invitation to attend. In any case, neither Inscale Technologies/AvSight nor any of its officers, employees, agents, contractor, members or representatives shall be liable for any loss, any alleged and/or actual claims, actions, lawsuits, proceedings, penalties, liability, damage or expense suffered or incurred by any person.

FORCE MAJEURE: Inscale Technologies/AvSight shall not be liable for delay or failure of performance or fulfillment of this Agreement caused by an act of God; action by any governmental or quasi-governmental entity; fire, flood or other disaster; pandemics and/or epidemics; nuclear, chemical or biological contamination; extreme weather conditions; public enemy; insurrection; riot; explosion; embargo; terrorist attacks; strikes whether legal or illegal; labor or material shortage; work slowdown; transportation interruption of any kind; authority of law; any Event building being destroyed or substantially damaged; or any other cause beyond

the control of Inscale Technologies/AvSight (“Force Majeure Event”). In the event the Event cannot be held or is postponed pursuant to this section, Inscale Technologies/AvSight shall not be liable to attendee for any damages, costs, or losses incurred, such as transportation costs, accommodations costs, or financial losses. Inscale Technologies/AvSight will refund registration fees paid.

Inscale Technologies/AvSight reserves the right to amend these terms and conditions (without notice) from time to time and you will be subject to the terms and conditions in force at the time that the Event is staged.

Additional Terms of Governing Partner Participation

AvSight is thrilled to have our partners in attendance at this event. We think it will be of benefit to our sponsors to participate fully, but we do ask you to remember that the primary focus of this event is AvSight users. With this in mind, Partner registration is subject to some specific terms.

- Partners are invited to participate in all general and breakout of the AvSight User Group Summit.
- In the case of space limited breakout sessions, we ask sponsors to allow AvSight Users priority in attending. If the number of users wishing to attend a breakout session exceeds the available space, a Partner attendee may be asked to give up their spot.
- Partners are welcome to participate in the event by submitting questions, but we ask that partners be respectful of the format of this user focused event and avoid self promotion during non-sponsored sessions or otherwise disrupting sessions.
- AvSight's flexible platform offers our users endless customization options. Some of our partners in attendance may offer similar solutions. We think highlighting key differences is a valuable tool to help users decide which solution is best for their business. However, we ask that all such discussions be respectful and positive.
- Partners must comply with all guidelines of the AvSight team and venue staff. Any Partner who refuses to comply may be removed from the event. In the case of such removal, Sponsor is not entitled to the refund of any portion of registration payment.
